Apparently, the substance of Madison Square Park Petition with 1543 signatures has yet to be acknowledged and considered when developing the emerging plan. As the petition represents a sizeable and significant grassroots input from the community for the Emerging Plan, it should not be set aside as inconsequential and tossed aside like it never existed. Instead, it should be construed as valuable information worthy of serious consideration. Further, when the Emerging Plan goes through the higher channels for approval, all decision makers should be aware that a large group of the populace is strongly in favor of keeping Madison Square Park as an open space park sans swimming pool, senior center, and or community center. Therefore, we request that words be developed to acknowledge the Petition and its substance for inclusion into the Emerging Plan and to amend the Emerging Plan as appropriate.

Regarding LMSAP, Draft Emerging Plan of September 2011, please accept/adopt the following comments:

1. On Page 1-7, 6. Community Facilities and Open Space, please add the following bullet:

Recognize and preserve the beneficial effects of Madison Square Park to the community as it represents a forum for (1) achieving good physical and mental health; (2) networking for socializing and making friends; getting help to assimilate into the mainstream; (4) promoting longevity through various exercises; and (5) physical ed activities for the nearby charter school.

2. On Page 5-7, Madison Square Park, please add that the Park is also used by the American Indian Model School (located on 12 St. and Madison) with a studentbody of over 200 for its physical education programs.

3. On Page 5-7, Madison Square Park, 2nd. Bullet, please remove swimming pool, senior center, and community center due to the lack of available space needed by present users; in lieu thereof replace with a walking/running track along the entire perimeter of the Park.

4. On Page 5-7, Madison Square Park , 5th. Bullet, please remove “a tea house” as it doesn’t make sense to have this type of operation at Madison Park.

Also, we are enclosing two attachments, the first is a copy of the letter dated September 12, 2011 to Mr. Ed Manasse transmitting our petition signed by 1543 people. The second is the petition itself sans signatures. The signed petition which we gave to Mr. Manasse represents an overwhelming number of interested parties who have step forward to voice that Madison Square Park remains essentially as is. Consequently, we request that the attachments be incorporated into the various other comments which will be made a part of the Emerging Plan going forward for approval. WHEREAS: The Park is a simple one block open space park where hundreds of seniors and working adults (from a base of over 1,000 people) come daily to the Park for tai chi and dozens of other types of activities and exercises;

Dear Mr. Ed Manasse:

Today at the Townhall Meeting at Laney College, the undersigned hereby delivers to you the enclosed Petitions, signed by 1,543 citizens who are resolutely in-favor of Madison Park remaining, in its entirety, an open space Park, free and clear of any development whatsoever including a community center.

For the record, let it be known that there have been proponents for a development alternative to use the Park site for a community center, housing, retail and/or commercial/office space. The Area Plan under review in today's Townhall Meeting excludes this alternative because it was too controversial at this juncture. However, we anticipate the proponents may continue to pursue inclusion of the said alternative in the Area Plan. If it becomes strategically necessary to illuminate the "public controversy" aspect of our plight, we will engage the news media for further assistance.

The People clearly want Madison Park to be open space as evidenced by the signed Petition. The American Indian Model School located at 12th. Street and Madison with over 200 students now uses the Park regularly. They too have stated that the Park should remain a Park.

Therefore, we urge that you, as Principal Planner, to advise both the City Council and BART that the inclusion of said development alternative would cause or result in a "Public Controversy" on the Park. As such, a full blown environmental impact statement may be required which may result in substantially greater cost and time to obtain environmental approval for the Area Plan. Also, we urge that you provide advice on existing legal statutes protecting parks and open space which may make the alternative problematic.


In responding to today's solicitation for public comments regarding the Area Plan, the enclosed signed Petition is, in essence, the submittal of 1,543 individual

comments, strongly advocating open space at Madison Park. We, collectively, fully support the development of a community center as well as more housing, but only on BART property adjacent to Madison Park. Consequently, we vigorously oppose "improve Madison Park with programming and possibly a community facility" as cited in today's Plan under review.

A community facility with programming (of activities by a director) is a specious proposal because that would change the present character of our Park which people have found it to be vibrant, successful, and worthy of replication. It is now an organic park where activities happen freely, spontaneously, and naturally, e.g., people are free to come at any time, do what ever interest them and for as long as they want. This fertile operation has born many individuals and activities which originated at Madison Park and later spilled over to Lincoln Rec Center. That spillage has, in fact, contributed greatly to the success of the Lincoln Rec. Those individuals, organizations, and activities are (1) Edward Yu (tai chi class); (2) Mr. Wong (tai chi class); (3) Vivienne Yu (Rising Dragon Martial Arts) and (Choral Group); Henry and Gaye Ying Kong (Calligraphy Class); Helen (Line Dancing); Tina and Maurice (Ballroom Dancing); as well as several other Chinese dance groups. So the present organic "cost free" operation at Madison Park is fine and needs no changing over to a programmatic type of operation. This status quo is also appropriate due to current difficult budgetary times.

We appreciate the opportunity to present our comments and concerns for Madison Park which we value so much.
