ORDINANCE IN RESPONSE TO SB 974 THIS ORDINANCE CODIFIES THE FOLLOWING FOUR (4) PROGRAMS: (1) LOCAL AND SMALL LOCAL; (2) LOCAL EMPLOYMENT; (3) PREVAILING WAGE and (4) APPRENTICESHIP PROGRAM REQUIREMENTS FOR CITY OF OAKLAND AND OAKLAND REDEVELOPMENT AGENCY CONTRACTS AND PUBLIC WORKS PROJECTS

WHEREAS, recently enacted Senate Bill 974, which amends the California Public Contracts Code (adds Pub. Contr. Code Sec. 1100.7), will require charter cities to adopt certain contract requirements for public works projects by charter provision or ordinance, or to adhere to state laws; and
