- A. Call to Order/Approval of Agenda**
G. Green called the meeting to order at 5:30pm.
- B. Roll Call/Determination of Quorum/Recite AC-OCAP Promise**
Roll call was called by staff C. Garcia. The AC-OCAP promise was recited. A quorum was established.

E. Clemons stated that the outcomes chart may be included in the October Administering Board packet.

E. Clemons stated that S. Allen who represented Alameda County has resigned. She also stated that the United Seniors of Alameda County has submitted a letter appointing S. Johnson-Simon to continue to represent them on the CAP board. She stated that there were three applicants in the audience who are interested in being on the AC-OCAP board. Carlos Jones who applied to represent District 2 introduced himself. E. Clemons stated his application will be in the October packet. Hang Mosier who applied to represent one of two of the vacant County of Alameda seats also introduced herself. Her packet will be in the October packet as well. Janice Heredia’s application was in the packet and she also introduced herself. **Motion:** To accept Janice Heredia as one of the Alameda County representatives on the AC-OCAP board. M/S/Carried: L. E. Diversity Training – Tiffany Hoang and Tyrone Botelho

T. Hoang and T. Botelho began their presentation by giving a background on themselves. They continued with their PowerPoint presentation discussing diversity, challenges in communities, equity, and equality. They shared a handout with this information that also included information on Microaggressions. The board then participated in various exercises.

F. Committee Reports – (Verbal):

1) Advocacy Committee – September 7, 2016 (S. Richardson)

S. Richardson stated that the committee members have made new commitments on which items they would like to report on. He also stated that the \$100,000 ASK letter has been referred to the Fund Development Committee. A. Gums stated that there was also discussion of tax exemptions for low-income seniors and the housing bond which will be on the November ballot. N. Lacy and A. Gums will be doing some outreach on the housing bond facts. E. Clemons stated that there has already been training on the housing bond measure. G. Green also agreed to have A. Gums on the Advocacy Committee. L. Ruhland suggested that the EITC sites be given a list of tax exemptions. There was also discussion on having transportation from Oakland to Hayward due to the civil court cases not being heard in Oakland and being moved to Hayward.

2) Fund Development Committee – September 7, 2016 (M. Rivera)

L. Wheeler stated that at the Fund Development meeting, there was discussion on no available resources for large events and how to get the public interested in AC-OCAP. E. Clemons stated that ideas from the Advocacy and Fund Development Committee should be referred to the Executive Committee. There was also discussion on tabling the consolidation of certain committees.
