IX. Staff Reports

X. Old Business

- A. Report back from December 4, 2013 Commission on Aging, (CoA) meeting and discussion on status of joint CoA/MCPD Access Compliance Advisory Committee (ACAC) and other collaborative efforts in 2014; Chairperson Beard reported:
 - Described the past efforts to create relationships with the Commission on Aging, CoA. Discussed that there are several quality of life issues which equally impact both seniors and persons with disabilities.
 - Chairperson Beard and Commissioner Blanks gave a presentation at the December 4, 2013 CoA meeting, its annual retreat, on the question if the joint CoA/MCPD ACAC experiment should continue in calendar year 2014.
 - Commissioners and staff discussed the risks and benefits of keeping the ACAC a joint committee. The CoA commissioners showed willingness toward affording the CoA leadership an additional opportunity to meet previously established attendance, participation and staffing goals.
 - The CoA is undergoing membership and staffing changes. It will come back in January 2014 to further discuss the future of the joint membership of the ACAC.

- B. Update on Letter of Support from the MCPD regarding the International Treaty on the Rights of Persons with Disabilities; Chairperson Beard reporting. (See Exhibit B).
 - In 2012, the U.S. Senate failed to ratify the Treaty by six votes. (It needed 66 votes in the Senate to be approved.) (Review MCPD December 10, 2013 minutes.)
 - o The U.S. Senate Foreign Relations Committee shall reexamine this Treaty during January 2014.
 - The importance of this Treaty is that it will allow the U.S. to fully participate and share in international technological advances that support positive quality of life for persons with disabilities.
 - Chairperson Beard has drafted a letter of support that will be addressed to the U.S. Senate, Committee on Foreign Relations and the two California Senators.
 - Motion: To approve the friendly letter supporting the ratification of the International Treaty on the Rights of Persons with Disabilities which shall be addressed to the U.S. Senate, Committee on Foreign Relations and the two California Senators.
 - Motion/Second: Commissioner Jacobs/Commissioner Burns
 - Motion passed by consensus.

XI. Special Order of Business: End of Year Retreat

- A. Chairperson Beard introduced the year end retreat by announcing the theme for the MCPD upcoming 2014 year, "Making a Difference". He told the commissioners to keep the theme in mind while participating in the retreat. Chairperson Beard introduced:
 - Facilitator Bill Pelter, Assistant Executive Director, Cerebral Palsy Center for the Bay Area, and former MCPD Commissioner who then led the commissioners and staff in discussion aimed at establishing a 2014 work plan.
 - o Mr. Pelter started the retreat with an ice-breaker.
 - o Chairperson Beard summarized the MCPD's actions of 2013.
 - He reminded the commission about the Conditions of Approval, COA for the Bus Rapid Transit, BRT which the Commission co-authored with the ADA Programs Manager and shepherded through the Oakland City

- Council. This makes A.C. Transit accountable to the disability community.
- Learned how City Council works and reached out to councilmembers and made them aware of the work of the commission. Prior to 2011, the commission had a much more quiet presence.
- The MCPD reached out to other City commissions and to the community, and outside organizations approached the MCPD for its participation in community events.
- Commissioner Beard stated that he wants the body to come out of the retreat with a stronger sense of what our role is as a commission going forward, (more than acting as an advisor to the Mayor and to the Council). What does this mean? How can MCPD make a difference?
- o Mr. Pelter led the commission through listing its Strengths, Weakness, Opportunities and Threats, SWOT. After discussion and examination of its SWOTs, the Commission formulated its top goals for 2014. They are as follows:

Priorities (Goals, Objectives, Projects For 2014)

Outreach:

- o Community outreach; becoming more of a household name with 'politicos' and other internal/external stakeholders.
- o Get social media up and running.
- o Become more of a channel for information for parents /families of children with disabilities with an emphasis on special education.
- Help destroy stigma surrounding mental illness (media, role modeling, jobs, etc.
- o Become a force in the local disability community.
- o More outreach to persons with disabilities around E-Prep.
- o Form independent relationship with City's Department of Human Services, DHS, and Education Partnership of City Council.

Employment:

o Move the bar on disability employment statistics thru our advocacy.

• Explore innovative strategies for engaging local government in employment of persons with disabilities.

Litigation Issues:

- Assist/speak out against serial litigation by Attorney Paul Rein against City.
- Reclaim MCPD/Staff discretion/time around use of ADA's staff and capital resources.

Maintain ACAC Standing Responsibilities:

- o More <u>awareness</u> of people with disabilities on <u>public transit</u>.
- o Improving Paratransit.

- Ms. Calabrese reported that the retreat was extremely successful and that all commissioners' participation was extremely impressive.
- All commissioners expressed their satisfaction with the retreat processes.
